(a) a worker may fall three metres or more; or

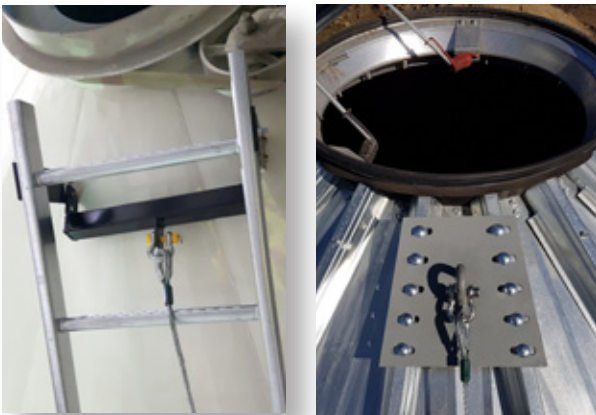
(b) there is a possibility of injury if a worker falls less than three metres."
